LODGEMENT

Before an application is lodged it is really important to decide what type of liquor license you need and what conditions you require. A number of issues to consider include capacity, hours of operation, car parking, food, entertainment, noise and public safety.



DOCUMENTATION

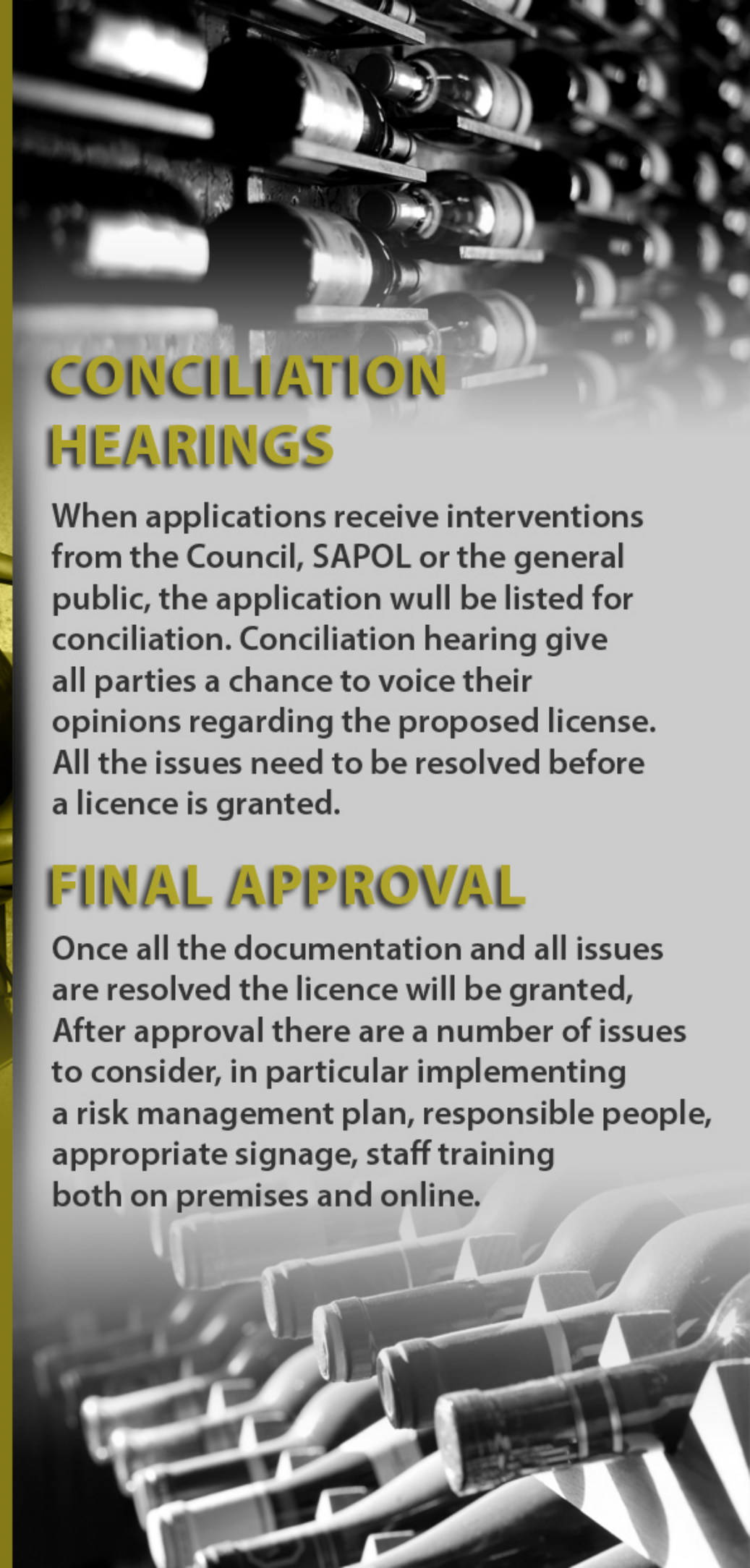
After the application is lodged there are a number of approvals and documents required before a license can be granted. These can include public notification, council consent, traffic reports, development & planning approval, Landlord consent, ASIC extracts, certificate of title and trading name registration.

CONCILIATION HEARINGS

When applications receive interventions from the Council, SAPOL or the general public, the application will be listed for conciliation. Conciliation hearing give all parties a chance to voice their opinions regarding the proposed license. All the issues need to be resolved before a licence is granted.

FINAL APPROVAL

Once all the documentation and all issues are resolved the licence will be granted, After approval there are a number of issues to consider, in particular implementing a risk management plan, responsible people, appropriate signage, staff training both on premises and online.
